MM also referred to the recent penalty notice from the Department of Planning & Environment (DoPE). MM reiterated that Hanson is seeking to apply for a modification to Schedule 2, Condition 6(b). BP explained that Hanson is applying to the DoPE for a modification to product dispatch truck levels, and that documentation was submitted to the DoPE for an adequacy review. Feedback from CCC members was generally positive with CCC members understanding the difficulty in managing the current restrictions. The CCC members were not concerned about potential safety impacts as the original restriction was based around potential school bus movements which have not eventuated and are no longer expected in the future. Having discussed the content of the modification in regards to the proposed changes in traffic movements, GDB voiced concerns in regards to the traffic movements between 5-6pm due to this being the usual time of travel for most residents returning from work. GDB suggested that the restriction of 6 movements per hour be maintained between 5-6pm (There was no concern in regards to number of movements between 	MM to notify the CCC members before submission of the modification.
