- 1 **Opening & Welcome** LA opened the meeting at 1.33pm and welcomed all attendees. CK was introduced as the CCS Quarry Supervisor.
- **2 Apologies** as listed above.
- **Declarations** LA declared that she is an approved Independent Chairperson by the Department of Planning & Environment, engaged by Hanson to chair the meeting. No changes to members' previous declarations.
- 4 Business arising from previous meeting minutes

The minutes from 5th November 2018 CCC were finalised and sent out on 22nd November 2018.

- DM advised that Central Coast Council has undertaken road maintenance recently. Repairs to some pot holes has not been successful, so this area is going to be cut out and rehabilitated. Residents are encouraged to log all complaints to Council's portal: ask@centralcoast.nsw.gov.au
 Traffic logger monitoring was undertaken in November 2018 with the average speed along Grants Rd showing as 67kmph. The highest recorded was 125kmph. RMS have lowered the speed limit from 100km to 80km, however Council's position is that it should be lower. There seems to be a lot of variances in speed limits on rural roads (Howes Rd is 60km, Wisemans Ferry Rd is 70km and Dog Trap Road is 80km). SH commented that the Hanson trucks are not going fast. BM advised of an orange truck (contractor) that appeared to be speeding. NG reiterated that contractor trucks are required to abide by Hanson's Code of Conduct. BM advised DM that Reservoir Rd is quite corrugated and that the entrance to Grants Rd requires a more permanent treatment. SH raised concern with pedestrian safety of school children. Discussions regarding road levy paid to Council (\$27k p/yr) with DM reiterating that funds assist in providing road maintenance to all Council roads. NG stated that the project consent conditions require funds to maintain local roads around the quarry. Action: LA to check conditions and make representations to Council.
- 2 Approval has been granted by Hanson to undertake vegetation screening for SH. SH is currently trying to source plants at wholesale prices for maximum coverage. BP advised that VGT (contractor) has undertaken dust monitoring (left at 2.04pm to get copy of results and returned at 2.05pm). BP is currently considering the draft report and results. Once the report is finalised it will provide an explanation of dust, dust monitoring and where crystalline silica sits. NG advised that health monitoring of staff is carried out. May look at putting a personal monitor on the boundary fence line. Action: Provide health information to CCC.
- 3 The Independent Environmental Audit has been undertaken reviewing the projects operations and monitoring from 2015 to 2018. Project update

- Skyland management update on rehabilitation of bund. Stage III plant out is finished (weed management and planting of the bund).
- Three full water cart tanks a week have been used; watering carried out every day. 2,200 plant investment (\$120k).

- JG raised an issue with a resident's driveway, where it joins the road, requiring tar to prevent dust. The house is located close to the road. DM suggested logging issue with Council and providing photographs to support request.
- BM discussed the noise issue with one of the loaders (quacker noise) that was leased late
 last year and caused concern. Due to the movement of the stockpiles he is hearing more
 noise early in the morning, which is impacting on his amenity (6am). NG advised that the
 old vehicle has returned following repairs which now has a squawker noise. NG advised
 that it would be difficult to mitigate, however, took the question on notice.
- NG informed the CCC that he is changing positions with Hanson and moving to the Midnorth Coast concrete operations. Paul Slough (previously with Calga & Brandy Hill will be the incoming Quarry Manager from 13/5/19. Charlotte Kelly (Quarry Supervisor) will be the primary contact for community representatives/complaints. Contact details:
