### **Open House Community Information Session**

The COVID-19 global pandemic has impacted the way in which we all carry out our daily lives, businesses and work – and Hanson is no exception.

To ensure the health and wellbeing of the community and staff is protected, Hanson has elected to heed the health warnings provided by both the Federal and State Governments. Where possible, staff will be working from home and, if in a group, personal space of at least 1.5 metres will be maintained.

A commitment to the community has been that Hanson will conduct an open house community information session following submission of existing conditions reports to the Technical Reference Group (TRG). With the next TRG meeting set as a teleconference for the end of March, Hanson planned to conduct a community information session early in April 2020 to present the following existing conditions reports:

- Groundwater Impact
- Planning
- Social Impact

or provide an opportunity for community members to discuss the proposed quarry with the Project Manager.

However, the ever changing requirements and regulations being driven by COVID-19 meant that every precaution to protect the health of community and staff needed to be undertaken.

Consequently, Hanson has committed to sharing information regarding the Environment Effects Statement (EES) studies on **Saturday 4 April 2020** as planned – except, rather than meeting at Bunyip Community Hall, the event will be conducted as a **telephone** event.
