\* BE: "Charlotte Kelly requested Roads & Maritime Services now Transport for NSW (TfNSW) to further reduce the speed on Grants Rd.

Council received confirmation from TfNSW that the speed limit would remain at 80km\h and requested Council investigate and ensure appropriate warning signs are in place to advise motorists of other potential road users in this vicinity.

I have received the following information from the Section Manager of the Traffic Section of Council:"As the pavement has been widened, we are proposing to improve the delineation of the road around the
corners to assist road users to maintain lane discipline.
Once the Local Traffic Committee (LTC) meetings are resumed, these proposals will be tabled.

The existing signage within Grants Road will also be assessed giving consideration to the new layout of the road."

This item will be ongoing subject to the LTC meeting."

# Compliance

#### **Environmental**

- Slashing / mulching of Western area of previous rehabilitation which was unsuccessful to take place in Mid-May in preparation for planting
- Rehabilitation / revegetation planting to begin June 2020 on the Western Area. 1100 Plants planned for June 2020 including species from Tall – small shrubs, tree species and herbs, grasses and forbs.

SH asked for an update on what was happening with the proposed planting for her property. **Action: PS to ring SH to discuss.** 

- Weed control program as per maintenance schedule throughout the operation.
- Pit 2 Rehab Maintenance weeding and replanting as required.

- PS thanked Central Coast Council for resurfacing and widening Grants Rd and Reservoir Rd with a 2 coat spray seal with asphalt applied to the 90 degree corners on Grants Rd and to the corner of Grants and Reservoir Rd.
