I am writing on behalf of our client, Rocla Materials Pty Ltd (Rocla) to provide a range of documents to the Department relating to various compliance issues for the above consent. The non-compliances referred to are those identified in the Independent Audit Report dated June 2009 prepared by Umwelt Australia Pty Ltd.

The bulk of the outstanding non-compliances with this consent relate either to the supply of documentation or the absence of correspondence from either the Director-General of your Department or the Department that he/the Department is satisfied with the outcomes/results nominated in the respective conditions.
