1. Introduction

This document has been prepared by Hanson Construction Materials Pty Ltd (Hanson) to fulfil the reporting requirements stipulated in *Schedule 3, Condition 31* of Project Approval MP 08_0143 (the Approval). A summary table of how Hanson meet the requirements of *Schedule 3, Condition 31* is provided below as **Table 1**.

Attention should also be drawn to other conditions in the Approval relevant to product transport, specifically *Schedule 2, Condition 7* and *Schedule 2, Condition 8*, which stipulate limits for annual volume of products transported and the numbers of laden trucks dispatched, respectively.

Extractive Material Transport

7. The Proponent must not permit to be transported from the site:
- (a) more than 4 million tonnes of quarry products in any calendar year; or
 - (b) more than 3 million tonnes of quarry products by road in any calendar year.

Transport of Products

8. The Proponent must limit the dispatch of trucks carrying quarry products or concrete from the site to the levels shown in Table 1.

2. Laden truck movements

Schedule 3, Condition 31 requires Hanson to publish records of laden truck movements from the site on an hourly, daily, weekly, monthly, and annual basis (see **Section 1**). The complete laden truck dispatch report is included as **Appendix A**. The compliance status of laden truck movements for the second quarter of 2023 (i.e. 01/04/2023 to 30/06/2023 inclusive) is discussed in **Section 2.1**, **Section 2.2**, **Section 2.3**, **Section 2.4**, and **Section 2.5**.

2.1. Hourly laden truck dispatch

There were no non-compliances with the hourly laden truck dispatch limits (*Schedule 2, Condition 8*) during the second quarter of 2023. There were eleven instances where shortcomings in the reporting software yielded apparent non-compliances, but investigation indicated that Hanson was indeed compliant with hourly laden truck dispatch limits:

- **05:00 to 06:00 on 18/04/2023:** there was one instance of an internal load, whereby the laden truck was not dispatched from site. The report indicated that 28 laden trucks were dispatched, an exceedance of the hourly limit of 27 laden trucks. Exclusion of the internal load yields a total of 27 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.
- **05:00 to 06:00 on 26/04/2023:** there was one instance of an internal load, whereby the laden truck was not dispatched from site. The report indicated that 28 laden trucks were dispatched, an exceedance of the hourly limit of 27 laden trucks. Exclusion of the internal load yields a total of 27 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.
- **05:00 to 06:00 on 02/05/2023:** there was one instance of an internal load, whereby the laden truck was not dispatched from site. The report indicated that 28 laden trucks were dispatched, an exceedance of the hourly limit of 27 laden trucks. Exclusion of the internal load yields a total of 27 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.
- **06:00 to 07:00 on 04/05/2023:** there were three instances of an internal load, whereby the laden truck was not dispatched from site. The report indicated that 39 laden trucks were dispatched, an exceedance of the hourly limit of 38 laden trucks. Exclusion of the internal loads yields a total of 36 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.
- **05:00 to 06:00 on 06/05/2023:** there was one instance of an internal load, whereby the laden truck was not dispatched from site. The report indicated that 24 laden trucks were dispatched, an exceedance of the hourly limit of 23 laden trucks. Exclusion of the internal load yields a total of 23 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.
- **05:00 to 06:00 on 13/05/2023:** there was one instance of an internal load, whereby the laden truck was not dispatched from site. The report indicated that 24 laden trucks were dispatched, an exceedance of the hourly limit of 23 laden trucks. Exclusion of the internal load yields a total of 23 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.
- **05:00 to 06:00 on 15/05/2023:** there was one instance of a 'split load', whereby one vehicle is ticketed twice at the weighbridge, typically because the vehicle was carrying different products in each trailer. The report indicated that 28 laden trucks were dispatched, an exceedance of the hourly limit of 27 laden trucks. Exclusion of the split load yields a total of 27 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.

- **05:00 to 06:00 on 19/05/2023:** there was one instance of an internal load, whereby the laden truck was not dispatched from site. The report indicated that 28 laden trucks were dispatched, an exceedance of the hourly limit of 27 laden trucks. Exclusion of the internal load yields a total of 27 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.
- **05:00 to 06:00 on 23/05/2023:** there was one instance of an internal load, whereby the laden truck was not dispatched from site. The report indicated that 28 laden trucks were dispatched, an exceedance of the hourly limit of 27 laden trucks. Exclusion of the internal load yields a total of 27 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.
- **05:00 to 06:00 on 03/06/2023:** there were two instances of an internal load, whereby the laden truck was not dispatched from site. The report indicated that 24 laden trucks were dispatched, an exceedance of the hourly limit of 23 laden trucks. Exclusion of the internal loads yields a total of 22 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.
- **05:00 to 06:00 on 29/06/2023:** there was one instance of an internal load, whereby the laden truck was not dispatched from site. The report indicated that 28 laden trucks were dispatched, an exceedance of the hourly limit of 27 laden trucks. Exclusion of the internal load yields a total of 27 laden trucks dispatched, which is compliant with the prevailing hourly laden truck dispatch limit.

2.2. Daily laden truck dispatch

There were no non-compliances with the daily laden truck limit (*Schedule 2, Condition 8*) during the second quarter of 2023. See **Appendix A** for the complete laden truck dispatch report.

2.3. Weekly laden truck dispatch

A weekly summary of laden truck dispatch is provided as **Table 2**. There is no applicable limit for weekly laden truck dispatch (*Schedule 2, Condition 8*), so compliance status is not applicable. See **Appendix A** for the complete laden truck dispatch report.

2.4. Monthly laden truck dispatch

A monthly summary of laden truck dispatch is provided as **Table 3**. There is no applicable limit for monthly laden truck dispatch (*Schedule 2, Condition 8*), so compliance status is not applicable. See **Appendix A** for the complete laden truck dispatch report.

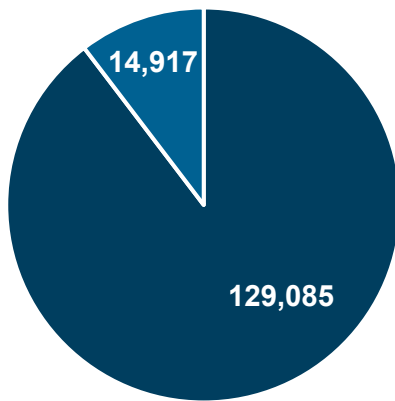
2.5. Annual laden truck dispatch

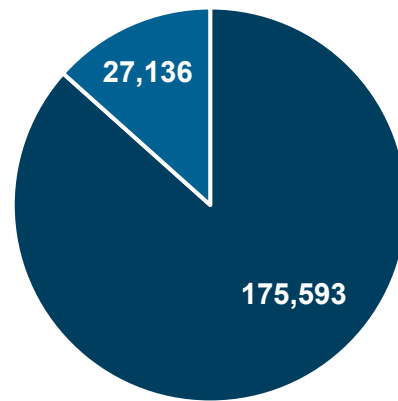
3. Regional destination of quarry products

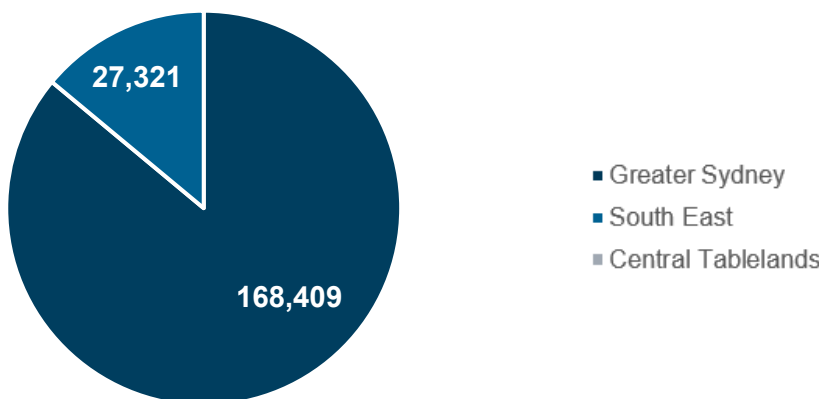


Figure 1: Volume of quarry products (tonnes) transported to different regional destinations for the months of (a) April 2023 [total 144,001 t]; (b) May 2023 [total 202,729 t]; and (c) June 2023 [total 195,730 t].

Schedule 3, Condition 31 requires Hanson to publish records of the monthly and annual volume of quarry products transported from the site, as well as the regional destination (see Section 1). To meet this requirement, customer delivery records were classified under the Local Land Services regions. Monthly volumes of quarry products transported from site to different regional destinations have been visually represented below (Figure 1(a), Figure 1(b), and Figure 1(c)). An annual summary of regional destination volumes (compared to Schedule 2, Condition 7) will be available in the report for the fourth quarter of 2023.
